In recognition of all the above, and in consideration of my use of facilities and programs offered by Seaboard Marina, I hereby assume all risk of injury and I release, discharge and hold Seaboard Marina, harmless from any liability resulting from injuries suffered by me arising out of my use, whether proper or improper, of the programs or facilities at Seaboard Marina. Further I voluntarily waive all rights to bring legal action against Seaboard Marina, or any of its agents or employees, or Seaboard Marina, for any cause related to my use of its programs or facilities. Also, the undersigned acknowledges that he/she is proficient in the Safety Check and understands and will abide by Seaboard Marina, Rules and Regulations as posted in the facility.
